

6th CPPTF Open Session
19 July 2021
Outcomes Report

Introduction

The 6th CPPTF Open Session was held online on 19 July 2021. The meeting was attended by 97 participants: 27 from the public sector, 24 from the private sector, 34 from observers/supporters/partners organizations, and 12 ICO staff. Item 1: Draft agenda

The [draft agenda](#) was approved and opening remarks made by Jose Sette, Executive Director of the ICO and ex-officio Chair of the CPPTF.

Item 2: Feedback from the 6th CPPTF Sherpas meeting June 30

The ICO Head of Operations presented an update about the latest discussions of the Task Force members at the Sherpas Only session held on 30 June 2021. He announced that the Sherpas:

- Approved the membership request received by Sustainable Harvest Coffee Importers.
- Endorsed the Proposal of Commitments & Targets for the Market Transparency technical workstream which will now be presented to the 103th ICC in September 2021 for their approval.

He also reported that Forum for the Future, a leading international sustainability non-profit organisation, will facilitate the 3rd CEO & Global Leaders Forum and that the Agenda proposal was in progress. Finally, a proposal was presented and signed off for CPPTF 2021 - 2022 meeting formats.
